

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Nation's "2012 Indian Housing Plan")**

**RESOLUTION NO. 12-111**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**  
2 **power to enact laws "to promote, protect and provide for public health, peace, morals,**  
3 **education and general welfare of the Tohono O'odham Nation and its members"**  
4 **(Constitution, Article VI, Section 1(c)(2)); and**

5 **WHEREAS, the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally designated**  
6 **housing entity in accordance with the Native American Housing Assistance and Self-**  
7 **Determination Act of 1996, 25 U.S.C. §4101, et seq., P.L. 104-330, 110 Stat. 4016**  
8 **("NAHASDA"); and**

9 **WHEREAS, to qualify for funds from the Indian Housing Block Grant Program, the NAHASDA**  
10 **requires submission of an annual Indian Housing Plan ("IHP") by the Indian tribe or**  
11 **by the tribe's designated housing entity (25 U.S.C §4112); and**

12 **WHEREAS, pursuant to Article IX of the Nation's TOKA Ordinance, 18 Tohono O'odham Code,**  
13 **Chapter 1, the TOKA shall submit annually to the United States Department of Housing**  
14 **and Urban Development's Southwest Area Office of Native American Programs**  
15 **("SWONAP") the Nation's Indian Housing Plan after review and approval by Legislative**  
16 **Council resolution (TOKA Ordinance, Article IX, 1.a., [http://tolc-](http://tolc-nsn.org/docs/Title18Ch1.pdf)**  
17 **nsn.org/docs/Title18Ch1.pdf); and**

18 **WHEREAS, under the direction of the TOKA's executive director, the TOKA prepared and**  
19 **submitted the Nation's "2012 Indian Housing Plan" for the program year beginning**  
20 **July 1, 2012 and ending June 30, 2013 to TOKA's Interim Board of Directors for review**  
21 **and approval (TOKA Ordinance, Article IX, 1, b., ii.); and**

22 **WHEREAS, after approving the Nation's "2012 Indian Housing Plan" by Resolution No. 03-07-12,**  
23 **the TOKA's Interim Board of Directors provided the IHP to the Legislative Housing**  
24 **Committee for review and approval (TOKA Ordinance, Article IX, 1, b., iii.); and**

25 **WHEREAS, the Legislative Housing Committee recommends approval of the Nation's "2012 Indian**  
26 **Housing Plan" for the program year beginning July 1, 2012 and ending June 30, 2013.**

27 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**  
28 **the Nation's "2012 Indian Housing Plan"; provided that any amendments are subject**  
29 **to Legislative Council review and approval.**


1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the  
2 Nation's Chairperson to sign the certification authorizing submission by the TOKA of  
3 the Nation's "2012 Indian Housing Plan."

4 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day  
5 of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-  
6 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article  
7 VI, Section 1 (c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
8 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
9 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
10 Stat. 984).


