

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Dr. Selso Villegas as Executive Director for
the Department of Water Resources)**

RESOLUTION NO. 12-116

1 **WHEREAS, Article VII, Section 2(e) of the Tohono O'odham Constitution empowers the Chairman,**
2 **with "the approval of the Tohono O'odham Council, to appoint the treasurer, and**
3 **other officers and heads of all governmental departments, who shall serve until**
4 **replaced at the request of the chairman"; and**


5 **WHEREAS, Chairman Ned Norris, Jr. has identified Dr. Selso Villegas as the appointee for the**
6 **Executive Director for the Department of Water Resources and the appointment has**
7 **been reviewed by the Legislative Water Resources Committee; and**

8 **WHEREAS, the Chairman has determined that Dr. Selso Villegas is qualified for the position of**
9 **Executive Director for the Department of Water Resources.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **approve the appointment of Dr. Selso Villegas as Executive Director for the**
12 **Department of Water Resources and Dr. Villegas shall serve until replaced at the**
13 **request of the chairperson of the Tohono O'odham Nation.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
15 **of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
17 **VII, Section 2 (e) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
18 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
20 **Stat. 984).**


