

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Tohono O'odham Department of Health and Human Services, Division  
of Behavioral Health, FY2012 Methamphetamine and Suicide Prevention  
Initiative(MSPI) Funding Award)**

**RESOLUTION NO. 12-123**

- 1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health provides**  
2 **substance abuse, mental health, and prevention services; and**
- 3 **WHEREAS, the Tohono O'odham Nation, HHSD, Division of Behavioral Health submitted an**  
4 **application to the U.S. Department of Health and Human Services for a**  
5 **Methamphetamine and Suicide Prevention Initiative (MSPI) award.**
- 6 **WHEREAS, the Nation was notified on June 24, 2009 that the Behavioral Health application was**  
7 **accepted for funding in the amount of \$300,000.00 for Years One and Two; Year One**  
8 **funding was in the amount of \$135,050.00 to be utilized for the funding period of**  
9 **October 1, 2009 to September 30, 2010; and Year Two MSPI funds were \$164,950.00 to**  
10 **be utilized for the period of October 1, 2010 to September 30, 2011; and**
- 11 **WHEREAS, the funds for Year One and Year Two were allocated as a lump sum of \$300,000.00 and**  
12 **approved by Resolution Number 09-489 by the Tohono O'odham Legislative Council**  
13 **on September 14, 2009; and**
- 14 **WHEREAS, the funds for Year Two included Carry Forward Funds from Year One which were**  
15 **approved on May 13, 2011, by Tohono O'odham Legislative Council Resolution Number**  
16 **11-185; and**
- 17 **WHEREAS, a separate notification was sent on September 30, 2010, modifying the Tohono**  
18 **O'odham Nation's Master P.L. 93-638 Contract HHS1249200400001C to incorporate**  
19 **MSPI Grant funds in the amount of \$163,485.00 to be utilized in FY2012, Year Three of**  
20 **the Award to be utilized in the period from October 1, 2011 to September 30, 2012.**
- 21 **WHEREAS, the approved funds aim to decrease the incidence of suicide and increasing the**  
22 **suicide crisis response capacity of the Tohono O'odham Nation by training**  
23 **gatekeepers in Applied Suicide Intervention Skills Training (ASIST) and by enhancing**  
24 **the response to and the surveillance, reporting and monitoring of, the Tohono**  
25 **O'odham Nation's members who are at risk for suicide; and**
- 26 **WHEREAS, adding a new position of Project Manager with a salary in the amount of \$54,510.00**  
27 **with fringe benefits; and**
- 28 **WHEREAS, the MSPI is a Congressional allocation and therefore the funding does not include**  
29 **indirect costs.**


1 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that:

- 2           **1. The Year Three Methamphetamine and Suicide Prevention Initiative (MSPI) funds**  
3           **in the amount of \$163,485.00 will be utilized in the period from October 1, 2011 to**  
4           **September 30, 2012.**
- 5           **2. Add new position Project Manager \$54,510.00 with fringe benefits.**
- 6           **3. The MSPI funds are from a Congressional allocation and therefore are not eligible**  
7           **for indirect funding cost.**

8 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes  
9           **the Chairperson and any designated official to expend and administer the budget as**  
10           **attached, provided that any amendments affecting the funds or funding level shall be**  
11           **submitted for further prior approval by the Tohono O'odham Legislative Council.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day**  
13 **of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
14 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**  
15 **VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
16 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
18 **18, 1934 (48 Stat. 984).**


