

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment #1 for Choulic Community's FY 2012 Budget)**

RESOLUTION NO. 12-124

1 WHEREAS, at a session of the Tohono O'odham Legislative Council, held on April 13, 2012; and
2 WHEREAS, Baboquivari District Representatives presented a budget amendment #1 for Choulic
3 Community's FY 2012 budget; and
4 WHEREAS, the amount of \$19,265.25 which was identified as Choulic Community's portion of FY
5 2012 Mining Royalties; and
6 WHEREAS, the budget amendment #1 would utilize the FY 2012 Mining Royalties, in the amount
7 of \$19,265.25 and will be applied to the following operational line item:

10 WHEREAS, this budget amendment #1 would increase the Choulic Community's FY 2012 original
11 budget amount of \$189,874.25 to a revised amount of \$209,139.50 and will also
12 increase the overall District's FY 2012 original budget of \$2,444,236.57 to a revised
13 amount of \$2,463,501.82.

14 NOW, THEREFORE, BE IT RESOLVED that this budget amendment #1 will increase Choulic
15 Community's FY 2012 original budget amount of \$189,874.25 to \$209,139.50 and will
16 also increase the overall District's FY 2012 original budget of \$2,444,236.57 to
17 \$2,463,501.82.

18 BE IT FINALLY RESOLVED that any modifications, amendments or changes in the justifications
19 shall be reviewed and approved by the Budget & Finance Committee and the Tohono
20 O'odham Legislative Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
22 of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-
23 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article
24 VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
25 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
27 Stat. 984).
