1 **WHEREAS, by Resolution 11-342, the Tohono O'odham Legislative Council (Council) approved and**
2 **authorized the KOHN 91.9 FM's Corporation for Public Broadcasting (CPB) Community**
3 **Service Grant (CSG) for fiscal year 2012; and**

4 **WHEREAS, KOHN has prepared the attached budget amendment two (2), incorporated into this**
5 **resolution by this reference, to obligate the final allocation of the grant, an increase**
6 **in the Community Services Grant in the amount of \$6,519.94; increasing the fiscal year**
7 **2012 KOHN CPB budget from \$198,021.06 to \$204,541.00; and**


8 **WHEREAS, KOHN management has presented the attached amendment two of its FY 2012 CPB CSG**
9 **grant to the Executive Office; the Cultural Preservation and Budget & Finance**
10 **Committees.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
12 **approves and authorizes Amendment two of KOHN 91.9 FM's CPB CSG FY 2012 budget**
13 **to be expended as attached; increasing the fiscal year 2012 KOHN CPB budget by**
14 **\$6,519.94 from \$198,021.06 to \$204,541.00.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Nation's Officials to-wit: the Chairman, and any designated official, are authorized to**
17 **execute the grant, provided however, that any amendments affecting the funds or**
18 **funding levels of the grant shall be submitted for further prior approval by the Tohono**
19 **O'odham Legislative Council**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
21 **of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
23 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**


