1 **WHEREAS, Sells District-Sells Community Resolution No. SC-255-11; Sells District Council**
2 **Resolution No. SD-97-11; Legislative Council Resolution No. 11-455 approved the Sells**
3 **District-Sells Community Fiscal Year 2012 Budget and its justification; and**

4 **WHEREAS, the Sells Community identified the need to amend the FY2012 Budget to address the**
5 **needs of the community; and**

6 **WHEREAS, Sells Community has prepared and acquired approvals of the attached budget**
7 **Amendment and its Justification with Sells Community Resolution No. SC-39-12; Sells**
8 **District Council Resolution No. SD-18-12.**


9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
10 **Sells District-Sells Community Fiscal Year 2012 Budget Amendment No. 1 of the**
11 **Gaming Revenues to increase the amounts of line items -655 Lodging by \$1,000.00; -862**
12 **General Assistance by \$5,000.00; -901 Wood by \$8,000.00; and include a new Line Item**
13 **-630 Insurance at an amount of \$500.00.**

14 **BE IT FURTHER RESOLVED that the increases will reduce the budgeted amounts for Line Items**
15 **- 727 Materials by (\$5,000.00); - 750 Major Capital by (\$8,000.00); - 852**
16 **Donation/Contribution (\$500.00); - 855 Consumables by (\$500.00); - 860 Special**
17 **Activities by (\$500.00) with no effects to the overall approved Sells District Fiscal Year**
18 **2012 Budgeted amount of \$1,660,996.79.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells**
20 **District Chairperson and any designated District Official to expend and administer the**
21 **budget, as attached, provided that any modifications or amendments affecting the**
22 **funds or funding levels of the budget shall be submitted for further prior approval by**
23 **the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
25 **of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
27 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
28 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
