

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Recognizing the Schuk Toak District Council Appointment of Anthony J. Rios as Alternate to  
Legislative Representative Frances Conde)**

**LEGISLATIVE ORDER NO. 12-138**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council to**  
2 **“enact laws and ordinances for conducting and regulating elections” and provides**  
3 **that the “decision of the Tohono O’odham Council in all election matters, including**  
4 **the eligibility and qualifications of candidates, shall be final” (Constitution, Article VI,**  
5 **Section 1(g) and Article X, Section 7); and**

6 **WHEREAS, during the May 28, 2011 general election Frances Conde was elected as Legislative**  
7 **Council representative for the Schuk Toak District but the alternate representative**  
8 **seat remained vacant; and**


9 **WHEREAS, on August 13, 2011, the Schuk Toak District Council appointed Anthony J. Rios to serve**  
10 **as Representative Frances Conde’s alternate on the Legislative Council (Schuk Toak**  
11 **District Council Resolution No. ST-08-13-11-131); and**

12 **WHEREAS, the Legislative Council, as a means of ensuring that each district is fully represented**  
13 **on the Legislative Council, has recognized district council appointments to vacant**  
14 **alternate seats in instances where vacancies have occurred outside of provisions**  
15 **expressly outlined in the Uniform Election Ordinance for filling vacancies.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O’odham Legislative Council that (1) it hereby**  
17 **recognizes the Schuk Toak District Council appointment of Anthony J. Rios to serve as**  
18 **alternate to Legislative Council Representative Frances Conde and (2) effective August**  
19 **13, 2011 seats Alternate Anthony J. Rios, who shall serve in accordance with the**  
20 **Constitution and laws of the Tohono O’odham Nation and with the rules and**  
21 **procedures of the Legislative Council when Representative Frances Conde is unable**  
22 **to attend a Legislative Council session.**

23 **The foregoing Order was passed by the Tohono O’odham Legislative Council on the 27<sup>TH</sup> day of**  
24 **APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
25 **[01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
26 **Section 1(g) and Article X, Section 7 of the Constitution of the Tohono O’odham Nation, adopted**  
27 **by the Tohono O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**
