(Recognizing the Pisinemo District Council Appointment of Tony Murrietta as Alternate to Legislative Representative Chester Antone)

LEGISLATIVE ORDER NO. 12-139

1	WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council t
2	"enact laws and ordinances for conducting and regulating elections" and provide
3	that the "decision of the Tohono O'odham Council in all election matters, includin
4	the eligibility and qualifications of candidates, shall be final" (Constitution, Article V
5	Section 1(g) and Article X, Section 7); and
6	WHEREAS, during the May 28, 2011 general election Chester Antone was elected as Legislativ
7	Council representative for the Pisimeo District but the alternate representative sea
8	remained vacant; and
9	WHEREAS, on July 19, 2011, the Pisinemo District Council appointed Tony Murrietta to serve a
10	Representative Chester Antone's alternate on the Legislative Council (Pisineme
11	District Council Resolution No. 11-P-14); and
12	WHEREAS, the Legislative Council, as a means of ensuring that each district is fully represented
13	on the Legislative Council, has recognized district council appointments to vacan
14	alternate seats in instances where vacancies have occurred outside of provision
15	expressly outlined in the Uniform Election Ordinance for filling vacancies.
16	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that (1) it hereb
17	recognizes the Pisinemo District Council appointment of Tony Murrietta to serve a
18	alternate to Legislative Council Representative Chester Antone and (2) effective Jul
19	19, 2011 seats Alternate Tony Murrietta, who shall serve in accordance with the
20	Constitution and laws of the Tohono O'odham Nation and with the rules and
21	procedures of the Legislative Council when Representative Chester Antone is unable
22	to attend a Legislative Council session.
23 24 25 26 27 28 29 30	The foregoing Order was passed by the Tohono O'odham Legislative Council on the <u>27TH</u> day o <u>APRIL</u> , <u>2012</u> at a meeting at which a quorum was present with a vote of <u>2,780.60</u> FOR; <u>-0-</u> AGAINST <u>[01]</u> NOT VOTING; and <u>[04]</u> ABSENT, pursuant to the powers vested in the Council by Article VI Section 1(g) and Article X, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
