

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY2012 Carry Forward Budgets for the One Stop Division of the Education
Department with the Arizona Department of Economic Security)**

RESOLUTION NO. 12-140

1 **WHEREAS, the Arizona Department of Economic Security entered into an intergovernmental**
2 **agreement (IGA) with the Tohono O'odham Nation to provide the Nation with funds for**
3 **specific Workforce Investment Act (WIA) employment and training programs operated**
4 **by the Education Department's One Stop Division; and**

5 **WHEREAS, the IGA was approved by this Legislative Council Resolution #11-182; and**

6 **WHEREAS, pursuant to the IGA, the Arizona Department of Economic Security has allocated funds**
7 **to the Nation for FY2011 in the amount of \$238,556.00 for the period beginning April**
8 **1, 2010 to June 30, 2012; and**

9 **WHEREAS, the One Stop Division has expended funds in FY11 leaving a total amount of**
10 **\$113,268.11 to be carried forward into FY12; and**

11 **WHEREAS, the One Stop Division has seven (7) program budgets and requests to expend these**
12 **budgets per attached budgets; and these budgets as identified in the following table**




