

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Nation's Support for an Independent Indian Health Service Audit of User**  
**Population Data and Collection Methods within the Tucson Area Office)**

**RESOLUTION NO. 12-141**

1 **WHEREAS, the Legislative Council is vested with the authority to “consult with the Congress of the**  
2 **United States and appropriate federal agencies regarding federal activities that affect**  
3 **the Tohono O'odham Nation. . .” and “to promote, protect and provide for public**  
4 **health, peace, morals, education and general welfare of the Tohono O'odham Nation**  
5 **and its members. . .” (Constitution, Article VI, Section 1(j) and Section 1(c)(2)); and**

6 **WHEREAS, based upon several serious concerns with the accuracy of data and with data**  
7 **collection methods, the Nation has previously objected to Indian Health Service user**  
8 **population estimates within the Tucson Area Office (Resolution No. 11-590); and**

9 **WHEREAS, during the course of several meetings with the Indian Health Service, the Health and**  
10 **Human Services Committee, in coordination with the Nation's Department of Health**  
11 **and Human Services, has discussed the possibility of an independent audit of data**  
12 **results and data collection methods within the Tucson Area Office; and**

13 **WHEREAS, the Indian Health Service, in collaboration with the Tucson Area Office and the Tohono**  
14 **O'odham Nation has agreed to perform an audit of the user population data results**  
15 **and data collection methods within the Tucson Area Office; and**

16 **WHEREAS, the Health and Human Services Committee recommends supporting the Indian Health**  
17 **Service's audit of user population data results and data collection methods within the**  
18 **Tucson Area Office.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it supports**  
20 **the Indian Health Service's audit of user population data results and data collection**  
21 **methods within the Tucson Area Office.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the**  
23 **Nation's Chairperson or official designee to provide recommendations to the Indian**  
24 **Health Service for the scope and purpose of the Indian Health Service's audit of user**  
25 **population data results and data collection methods within the Tucson Area Office.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
27 **of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**  
29 **VI, Section 1 (j) & (c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**






