Program Award, Grant Agreement No. 888415-02 for Overtime and Mileage in the  
amount of \$280,000.00)**

**RESOLUTION NO. 12-142**

1 **WHEREAS, the Arizona Department of Homeland Security is the State Administrative Agency**  
2 **authorized by the Governor of Arizona to serve as the “pass-through” agency for the**  
3 **United States Department of Homeland Security Homeland Security grant funding;**  
4 **and**

5 **WHEREAS, the Arizona Department of Homeland Security manages United States Department of**  
6 **Homeland Security grant programs for eligible local, Tribal and state agencies within**  
7 **Arizona; including several specialized grant programs such as the Operation**  
8 **Stonegarden (OPSG); and**

9 **WHEREAS, the Arizona Department of Homeland Security requires grantees who receive awards**  
10 **to enter into a Sub Grantee Agreement, which said agreement has been reviewed and**  
11 **approved to form by the Attorney General's office; and**

12 **WHEREAS, the Tohono O'odham Nation has been awarded Grant No. 888415-02, titled FY 2011**  
13 **Operation Stonegarden Grant Program Award - Overtime and Mileage, in the amount**  
14 **of \$280,000.00 effective January 1, 2012 through March 31, 2013; and**

15 **WHEREAS, this budget will carry forward into Fiscal Year 2013 and will terminate on March 31,**  
16 **2013; and**

17 **WHEREAS, the Tohono O'odham Nation Police Department has prepared a budget in the amount**  
18 **\$280,000.00 of which has been reviewed by the Budget Office, Grants & Contracts,**  
19 **Executive Office, Domestic Affairs Committee and Budget & Finance Committee, of all**  
20 **which recommend acceptance by the Tohono O'odham Legislative Council; and**

21 **WHEREAS, Indirect Costs are not allowable under the Arizona Department of Homeland Security**  
22 **Grants Programs.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
24 **accepts, approves, and authorizes the Sub Grantee Agreement for Grant Award No.**  
25 **888415-02 in the amount of \$280,000.00 from the Arizona Department of Homeland**  
26 **Security under the FY 2011 Operation Stone Garden Program for the period of January**  
27 **1, 2012 through March 31, 2013 for Overtime and Mileage.**

28 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council authorizes the Tohono**  
29 **O'odham Nation to expend funds from the attached budget hereto in the amount of**  
30 **\$280,000.00 for the period of January 1, 2012 through March 31, 2013 on a**  
31 **reimbursement basis and in accordance with the 2011 Operation Stone Garden**

2                   **grant.**

3 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**  
4                   **Chairman and any designated official to negotiate and execute Sub Grantee**  
5                   **Agreement for Grant Award No. 888415-02, provided however any amendments**  
6                   **affecting the funds or funding level shall be submitted for further prior approval by**  
7                   **the Tohono O'odham Legislative Council.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup> Day**  
9 **of APRIL, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0-**  
10 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article**  
11 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
12 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
13 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
14 **Stat. 984).**


