2		O'odham Voice in the Use of Gaming Revenues" (Initiative), which authorizes per
3		capita payments to the Nation's members provided that sufficient gaming revenues
4		are available; and
5	WHEREAS,	the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham
6		Nation ("Gaming Ordinance") was subsequently amended to authorize per capita
7		distribution payments in accordance with the Initiative (See Legislative Council
8		Resolution No. 97-303); and
9	WHEREAS,	the Legislative Council adopted the Per Capita Revenue Allocation Plan for a per
10		capita distribution per Legislative Council Resolution No. 09-164; and
11	WHEREAS,	the Chairman of the Nation received written notification from the Department of the Chairman of the
12		Interior on June 15, 2009 that Nation's Revenue Allocation Plan is approved; and

15		members for review and approval for a fourth per capita distribution; and
16	WHEREAS,	pursuant toResolutionNo.09-428whichapprovedtheMasterList forcertification, the
17		initial number of verified adult eligible members for the fourth per capita distribution
18		is 19,141; and
19	WHEREAS,	the Enrollment Program presented Resolution 12-102 to the Tohono O'odham
20		Legislative Council and requested that 8 additional eligible adults members be
21		certified for the fourth per capita distribution; and
22	WHEREAS,	there was an error on Resolution 12-102 in that there are 7, not 8 eligible adult
23		members requiring certification for the fourth per capita distribution; and
24	WHEREAS,	the disbursement of funds to each eligible adult member is contingent upon
25		$verification \ of \ a \ member\ and\ certification\ by \ the\ Tohono\ O'odham\ Legislative\ Council.$
