

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution 12-102. the Certification of Additional Tohono**  
**O'odham Nation Eligible Adult Members for the Fourth Per Capita Distribution")**

**RESOLUTION NO. 12-149**

1 **WHEREAS, on June 28, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**  
2 **O'odham Voice in the Use of Gaming Revenues" (Initiative), which authorizes per**  
3 **capita payments to the Nation's members provided that sufficient gaming revenues**  
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**  
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**  
7 **distribution payments in accordance with the Initiative (See Legislative Council**  
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council adopted the Per Capita Revenue Allocation Plan for a per**  
10 **capita distribution per Legislative Council Resolution No. 09-164; and**

11 **WHEREAS, the Chairman of the Nation received written notification from the Department of the**  
12 **Interior on June 15, 2009 that Nation's Revenue Allocation Plan is approved; and**

13 **WHEREAS, the Nation's Department of Membership Services, Enrollment Program submits to the**  
14 **Tohono O'odham Legislative Council the certification Listing for eligible adult**  
15 **members for review and approval for a fourth per capita distribution; and**

16 **WHEREAS, pursuant to Resolution No. 09-428 which approved the Master List for certification, the**  
17 **initial number of verified adult eligible members for the fourth per capita distribution**  
18 **is 19,141; and**

19 **WHEREAS, the Enrollment Program presented Resolution 12-102 to the Tohono O'odham**  
20 **Legislative Council and requested that 8 additional eligible adults members be**  
21 **certified for the fourth per capita distribution; and**

22 **WHEREAS, there was an error on Resolution 12-102 in that there are 7, not 8 eligible adult**  
23 **members requiring certification for the fourth per capita distribution; and**

24 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**  
25 **verification of a member and certification by the Tohono O'odham Legislative Council.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**  
27 **Resolution 12-102 and certifies 7 eligible adult members for the fourth per capita**  
28 **distribution.**
