# **LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**

(Amending Legislative Rules of the Tohono O'odham Legislative Council)

## LEGISLATIVE ORDER NO. 12-150

1	WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative					
2	Council with the power to establish rules and procedures to regulate all meetings of					
3	the Council and its standing committees (Constitution of the Tohono O'odham Nation,					
4	Article VI, Section 1(a)); and					
5	WHEREAS, the Legislative Council has exercised this power by adopting and amending the					
6	Legislative Rules of the Tohono O'odham Legislative Council (Legislative Rules), which					
7	include the process for presenting laws that have been adopted by the Council to the					
8	Nation's chairperson as required by Article VII, Section 5 of the Constitution; and					
9	WHEREAS, it is in the Legislative Council's best interest to amend Legislative Rules Article IX,					
10	Section 1(B) in accordance with the attached Legislative Rules amendments as dated					
11	for reference May 2012 in order to confirm the existing practice that: "A legislative					
12	action presented to the Nation's Chairperson for approval shall be accompanied by					
13	a copy of any document that was provided in support of the action or that was					
14	approved by that action."					
15	NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby adopts					
16	the Legislative Rules amendments as dated for reference May 2012.
