

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Amendments to the Amended Judicial Appointment Procedure)**

LEGISLATIVE ORDER NO. 12-152

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**
2 **Council with the power to establish rules and procedures to regulate all meetings of**
3 **the Council and its standing committees (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Council is further vested with the power to appoint judges to the**
6 **Tohono O'odham Judicial Court pursuant to Article VIII, Section 3 of the Constitution**
7 **of the Tohono O'odham Nation; and**

8 **WHEREAS, pursuant to Legislative Order No. 03-204, the Legislative Council adopted the Amended**
9 **Judicial Appointment Procedure governing the process for appointing Tohono**
10 **O'odham Judicial Court judges; and**


11 **WHEREAS, the Judiciary Committee recommends the adoption of the amendments appearing in**
12 **the "Amended Judicial Appointment Procedure," which is dated May 2012 and which**
13 **is incorporated by this reference, to further clarify the appointment process; and**

14 **WHEREAS, the "Amended Judicial Appointment Procedure" amendments incorporate input**
15 **provided during Legislative Council's March 2012 general session, and the**
16 **amendments have been jointly reviewed by the Judiciary Committee and Rules**
17 **Committee.**

18 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it adopts the**
19 **amendments appearing in the "Amended Judicial Appointment Procedure" as dated**
20 **May 2012, which shall become effective immediately and shall govern the Legislative**
21 **Council's process for appointing judges to the Tohono O'odham Judicial Court.**

22 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 08TH day of**
23 **MAY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**
25 **Section 1(a) and Article VIII, Section 3 of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**


