## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Approving FY 2012 Department of Health and Human Services Title IV-B, Subparts 1 & 2 Carry Forward Budgets for Division of Child Welfare Services, Approving the 10% Indirect Cost Rate for Title IV-B Budgets)

RESOLUTION NO. 12-156

1	WHEREAS, the Tohono O'odham Nation has operated a Division of Child Welfare Services to
2	intervene against child abuse and neglect and to promote safe and stable families; and
3	WHEREAS, these Title IV-B, Subparts 1 & 2 budgets are authorized for only a two year expenditure
4	period, beginning October 1, 2011 and ending September 30, 2012, funding only the
5	two fiscal year of FY 2011 and FY 2012; and
6	WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and
7	Families (ACF), has notified the Nation that the Child and Family Services
8	Improvement Act of 2006 (Public Law 109-288) restricts administrative costs to 10%
9	starting October 1, 2007 for Title IV-B budgets, and the Department requests approval
10	to submit these budgets with the following restricted 10% amount for direct costs; and
11	WHEREAS, allowing the Division of Child Welfare to create operational expenses to utilize the
12	carry forward budgets for:
13	1. Title IV-B, Subpart 1 budget with an operational expense budget in the amount of
14	\$20,379.09 with a 10% IDC of \$1,537.91 for a total of \$21,917.00.
15	2. Title IV-B, Subpart 2 budget with an operational expense budget in the amount of
16	\$46,865.45 with an Indirect Cost at 10% of \$3,686.55 for a total of \$50,552.00; and
17	WHEREAS, the Health and Human Services Committee and Budget and Finance Committee of the
18	Legislative Council have reviewed this budget and recommend its approval and
19	adoption.
20	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approve the FY
21	2012 Department of Health and Human Services Title IV-B, Subparts 1 & 2 Carry
22	forward budgets with an Indirect Cost to reflect the restricted 10% for Title IV-B
23	budgets, in the amounts of \$21,917.00 for Title IV-B, Subpart 1 budget and \$50,552.00
24	for Title IV-B, Subpart 2 budget.
25	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
26	Chairman and any designated official to expend and administer the budget, as
27	attached, provided that any amendments affecting the funds or funding level shall be
28	submitted for further prior approval by the Tohono O'odham Legislative Council.
