

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting May 2012 Enrollment Ordinance Amendments)

RESOLUTION NO. 12-158

1 **WHEREAS, the Legislative Council is vested with the power to “enact laws and ordinances**
2 **governing . . . the relinquishment and loss of membership” (Constitution of the**
3 **Tohono O’odham Nation, Article VI, Section 1(h)); and**

4 **WHEREAS, Article IX, Section 2 of the Enrollment Ordinance, Ordinance No. 05-81, as amended,**
5 **provides for the loss of membership in the Tohono O’odham Nation on grounds of dual**
6 **enrollment or when enrollment was based upon incorrect or omitted information;**


8 **WHEREAS, the Rules Committee, in consultation with the Legislative Council officers, has**
9 **developed the attached May 2012 Enrollment Ordinance Amendments, which are**
10 **incorporated by this reference, to clarify the process under Section 2(E) of Article IX**
11 **of the Enrollment Ordinance for a judicial appeal of an enrollment revocation; and**

12 **WHEREAS, the Rules Committee recommends that the May 2012 Enrollment Ordinance**
13 **Amendments be adopted.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council hereby adopts**
15 **the May 2012 Enrollment Ordinance Amendments.**

16 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 09TH Day**
17 **of MAY, 2012 at a meeting at which a quorum was present with a vote of 2,695.70 FOR; 84.90**
18 **AGAINST; [02] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
19 **Article II and Article VI, Section 1 (h) of the Constitution of the Tohono O’odham Nation, adopted**
20 **by the Tohono O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
