3	the Council and its standing committees (Constitution of the Tohono O'odham Nation
4	Article VI, Section 1(a)); and
5	WHEREAS, the Tohono O'odham Legislative Council is further vested with the power to "enac
6	laws and ordinances governing the relinquishment and loss of membership
7	(Constitution of the Tohono O'odham Nation, Article VI, Section 1(h)); and
8	WHEREAS, Article IX of the Enrollment Ordinance, Ordinance No. 05-81, as amended, provides fo
9	the loss of membership in the Tohono O'odham Nation on grounds of dual enrollmen
10	or when enrollment was based upon incorrect or omitted information; and
11	WHEREAS, by Resolution No. 03-406, the Legislative Council adopted "Rules of Procedure fo
12	Enrollment Revocation Hearings" to govern hearings concerning persons whos
13	membership in the Tohono O'odham Nation has become lost or abandoned by virtu
14	of dual enrollment or enrollment based upon incorrect or omitted information
15	pursuant to Article IX, Section 2 of the Enrollment Ordinance; and
16	WHEREAS, pursuant to Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation
17	the Rules Committee has drafted amended revocation hearing procedures fo
18	adoption by legislative order and the Committee therefore recommends that th
19	Legislative Council repeal Resolution No. 03-406.
20	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereb
21	repeals Resolution No. 03-406, "Rules of Procedure for Enrollment Revocation
22	Hearings."
23	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $09^{ ext{TH}}$ Da
24	of MAY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST

26	Section 1 (a) & (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohon

28	Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (4
