RESOLUTION NO. 12-162

1 **WHEREAS, the Tohono O'odham Nation was awarded and accepted the U.S. Department of Justice**
2 **(USDOJ), Office of Community Oriented Policing Service (COPS) Technology Program**
3 **Grant in the amount of \$100,000.00 under TOIC Resolution No. 11-096; and**

4 **WHEREAS, the grant award period is from December 16, 2009 through December 15, 2012; and**

5 **WHEREAS, the Tohono O'odham Nation has created a FY 2012 budget in the amount of**
6 **\$100,000.00; and**

7 **WHEREAS, this grant does not allow for Indirect Cost; and**


8 **WHEREAS, this budget has been reviewed by the Budget Office, Grants & Contracts, Executive**
9 **Office, Domestic Affairs Committee and Budget & Finance Committee, of all which**
10 **recommend acceptance by the Tohono O'odham Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
12 **approves the FY 2012 U.S. Department of Justice Office of the Community Oriented**
13 **Policing Services Technology Program Grant budget as attached in the amount of**
14 **\$100,000.00 with no Indirect Cost.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
16 **Chairman and any designated official to expend and administer the budget as**
17 **attached, provided that any amendments affecting the funds or funding level shall be**
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
20 **of MAY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Article VI,**
22 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
23 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


