1 **WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP) has been beneficial in**
2 **providing financial assistance to eligible low-income households in meeting utility**
3 **needs, i.e., electricity, propane, water and wood; and**

4 **WHEREAS, the allocation to the Tohono O'odham Nation for FY2013 through the State of Arizona,**
5 **Department of Economic Security, Division of Aging and Adult Services - Community**
6 **Action Program is \$62,572.00; and**

7 **WHEREAS, the Tohono O'odham Nation is hereby submitting the FY2013 budget for funding**
8 **through the State of Arizona, Department of Economic Security, Division of Aging and**
9 **Adult Services - Community Action Program in the amount of \$62,572.00 for contract**
10 **period July 01, 2012 through June 30, 2013; and**

11 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
12 **of the Legislative Council have reviewed this budget and recommends its approval and**
13 **adoption.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
15 **authorizes the expenditure of the FY2013 Low Income Home Energy Assistance**
16 **Program (LIHEAP) budget in the amount of \$62,572.00 in accordance with the attached**
17 **budget.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the budget as**
20 **attached, provided that any amendments affecting the funds or funding level shall be**
21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
23 **of MAY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; ~~0~~- AGAINST;**
24 **~~0~~- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
25 **Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
