8	budget as attached and incorporated by this reference, to be effective July 1, 2012
9	through June 30, 2013 and request authorization to expend funds First Things First
10	Family Support/Child Development Budget with IDC rate amount of \$16,436.27 for a
11	total budget of \$200,000.00; and
12	WHEREAS, the budget has been reviewed by the Budget Office, Grants & Contracts, Executive
13	Office, Health Committee and Budget & Finance Committee of all which recommend
14	for acceptance by the Legislative Council.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
16	the First Things First Family Support/Child Development Budget for the Period July
17	1, 2012 through June 30, 2013.

19	Executive Branch to expend funds for the program listed above and as attached in the
20	amount indicated, effective July 1, 2012 through June 30, 2013.
