**(Approval of the Emergency Funding Allocation from Indian Health Services**  
**of \$200,000.00 for addressing the Rocky Mountain Spotted Fever**  
**(RMSF) declared outbreak)**

**RESOLUTION NO. 12-167**

1 **WHEREAS, the Tohono O'odham Nation declared an outbreak of the Rocky Mountain Spotted**  
2 **Fever (RMSF) on the Tohono O'odham Nation by Resolution No. 11-555 on November**  
3 **2011; and**

4 **WHEREAS, in the same resolution, the Tohono O'odham Nation formally requested the assistance**  
5 **of the Indian Health Services and the Center for Disease Control (CDC) as well as the**  
6 **Arizona Department of Health Services and Pima County Health Department; and**

7 **WHEREAS, emergency funding was requested from Indian Health Services, Doctor Yvette**  
8 **Roubideaux, Director of Indian Health Service; and**

9 **WHEREAS, funds were received from Indian Health Services in the amount of \$200,000.00 assign**  
10 **to Management of Health (MOH) contract and the indirect it has been waived due to**  
11 **direct emergency funding from the agency; and**

12 **WHEREAS, a budget of \$200,000.00 has been developed in conjunction with the Tohono O'odham**  
13 **Nation Police Department and Natural Resource Department; and**

14 **WHEREAS, RMSF Emergency Funding budget has been reviewed by the Budget Office, Grants &**  
15 **Contracts, Executive Office, Health Committee and Budget & Finance Committee of all**  
16 **which recommend for acceptance by the Legislative Council.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
18 **approves:**

- 19 **1. A FY2012 \$200,000.00 budget to address the Rocky Mountain Spotted Fever**  
20 **outbreak on the Tohono O'odham Nation and has received an allocation from**  
21 **Indian Health Services.**
- 22 **2. Be it further resolved that the Tohono O'odham Legislative Council waives the**  
23 **indirect cost for the budget as funding received directly from Indian Health**  
24 **Services.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the budget as**  
27 **attached, provided that any Amendments affecting the funds or funding level is**  
28 **submitted for further prior approval by the Tohono O'odham Legislative Council.**




