1 **WHEREAS, the Tohono O'odham Legislative Council at a regularly scheduled meeting reviewed**  
2 **a budget amendment/modification for Pisinemo District FY 2012 Administration**  
3 **budget; and**

4 **WHEREAS, the Pisinemo District Administration submitted a proposal to deduct \$37,500.00 from**  
5 **certain line items to cover over expenditures and create a new line item for Major**  
6 **Capital Equipment; and**

7 **WHEREAS, deductions were made from the following line items and amounts:**

21 **Pisinemo District FY 2012 Administration Budget Modification #2/Amendment #1 for**  
22 **\$37,500.00**

23 **BE IT FINALLY RESOLVED that any amendments affecting the funds or funding level shall be**  
24 **submitted for further prior approval by the Tohono O'odham Legislative/District**  
25 **Council.**

27 **of MAY, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
28 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
29 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**
