

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting May 18, 2012 Special Session to Appoint Candidates to the Tohono O'odham Ki:ki  
Association Board of Directors)**

**LEGISLATIVE ORDER NO. 12-170**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**


5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**  
6 **the authority to "by majority vote, call for a special session" (Legislative Rules of the**  
7 **Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, the Housing Committee has requested a special session on May 18, 2012 to appoint**  
9 **candidates to the Tohono O'odham Ki:ki Association Board of Directors.**

10 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
11 **special session on May 18, 2012 to appoint candidates to the Tohono O'odham Ki:ki**  
12 **Association Board of Directors.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> day of**  
14 **MAY, 2012 at a meeting at which a quorum was present with a vote of 2,438.60 FOR; -0- AGAINST;**  
15 **-0- NOT VOTING; and 342.0[05] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
16 **Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
17 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
18 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
