8	has prepared the attached budget to authorize use of these revenues; and
9	WHEREAS, it is necessary for KOHN to request approval from the Tohono O'odham Legislative
10	Council to expend the amount deposited into the Dedicated Revenue Account 044-12-
11	1071 for Public Relations purposes; and
12	WHEREAS, the Cultural Preservation Committee and the Budget and Finance Committee of the
13	Legislative Council have reviewed this Budget and recommend its approval and
14	adoption.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
16	and authorizes KOHN to expend the Dedicated Revenue Account 044-12-1071 for
17	Public Relations expenses as provided in the attached budget, for the period of
18	October 1, 2011- September 30, 2012.
19	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
20	Chairperson and any designated official to expend and administer the budget as
21	attached, provided that any amendments affecting the funds or funding level shall be
22	submitted for further prior approval by the Tohono O'odham Legislative Council.
