7	matching funds in the amount of \$200,000.00 from its Investment Operating Account
8	for the purpose of funding a portion of the attached Housing Plan; and
9	WHEREAS, Tohono O'odham Ki:ki Association has adopted a 50-50 District Challenge in which
10	TOKA will match a district dollar for dollar up to \$200,000.00 for housing projects; and
11	WHEREAS, Pisinemo District Council also approved the attached list of District Housing
12	Renovation Projects (Housing Plan) in the total amount of \$400,000.00.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
14	the \$200,000.00 matching funds between the Tohono O'odham Ki:ki Association and
15	the Pisinemo District for a total of \$400,000.00 to be used on Housing Renovation
16	Projects.
17	BE IT FURTHER RESOLVED that the Pisinemo District has sufficient funding in its Investment
18	Operating Account to cover the 50-50 funding match for the calendar year starting
19	January 2012 to December 2012.
20	BE IT FINALLY RESOLVED that any amendments affecting the funds or funding levels of this budget
21	shall be submitted to the Pisinemo District and the Tohono O'odham Legislative
22	Council for further prior approval.
