12	line item No. 915 New Home Construction as the match; and
13	WHEREAS, San Xavier District representatives met with the Tohono O'odham Legislative Council's
14	Budget & Finance Committee on May 14, 2012 to review the San Xavier District's
15	amendment request, and recommended that it be forwarded to the Tohono O'odham
16	Legislative Council for approval.
17	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
18	the San Xavier District's FY12 Budget Amendment adding TOKA funds in the amount
19	of \$200,000 to the District's new line item No. 815 — Housing TOKA 50/50 Grant.
20	BE IT FINALLY RESOLVED that the San Xavier District's FY12 Budget's new grand total is increased
21	by \$200,000 from \$13,715,427.42 to \$13,915,427.42.
