7		"TERO Commission") and vesting the Council with the power to select and appoint
8		TERO commissioners (TERO Ordinance, Ordinance No. 01-85, Section 6(B)(2)); and
9	WHEREAS,	Section 6(C) of the TERO Ordinance further provides that "[c]ommissioners shall be
10		appointed for terms of three years, or until their successors are appointed and
11		${\bf qualified, provided, however, that  appointments  to  the  Commission  shall  be  made  in  the  commission  shall  the  commissi$

13		office of only two Commissioners will end in any single year"; and
14	WHEREAS,	Willard Anita was appointed to the TERO Commission with a term expiring February
15		1,2012 but Mr. Anita resigned June 9, 2011, creating a vacancy (Resolution No. 09-050);

17	WHEREAS,	the Domestic Affairs Committee has been delegated authority to "review and
18		recommend action by the Legislative Council on appointments of TERO
19		Commissioners" (Plan of Operation for the Domestic Affairs Committee, Article III.D.
20		as adopted by Legislative Order No. 01-431); and
21	WHEREAS,	the Domestic Affairs Committee has interviewed qualified TERO Commission
22		applicants, one of whom, when appointed, will serve a term commencing on the
23		$effective \ date \ of this \ resolution \ and \ expiring \ February \ 1, 2015 \ or \ until \ his \ successor \ is$
