

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Norman Garcia to the TERO Commission for a Term Expiring February 1, 2015)**

RESOLUTION NO. 12-193

- 1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers and agents" (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 1(b)); and**
- 5 **WHEREAS, in 1985 the Papago Council enacted the Papago Employment Rights Ordinance ("TERO**
6 **Ordinance"), thereby establishing the Papago Employment Rights Commission (a.k.a.,**
7 **"TERO Commission") and vesting the Council with the power to select and appoint**
8 **TERO commissioners (TERO Ordinance, Ordinance No. 01-85, Section 6(B)(2)); and**
- 9 **WHEREAS, Section 6(C) of the TERO Ordinance further provides that "[c]ommissioners shall be**
10 **appointed for terms of three years, or until their successors are appointed and**
11 **qualified, provided, however, that appointments to the Commission shall be made in**
12 **such a way and for such terms that their terms shall be staggered so that the terms of**
13 **office of only two Commissioners will end in any single year"; and**
- 14 **WHEREAS, Sandra Johnson was appointed to the TERO Commission with a term expiring February**
15 **1, 2012 and she continues to serve until her successor is appointed and qualified**
16 **(Resolution No. 10-128); and**
- 17 **WHEREAS, the Domestic Affairs Committee has been delegated authority to "review and**
18 **recommend action by the Legislative Council on appointments of . . . TERO**
19 **Commissioners" (Plan of Operation for the Domestic Affairs Committee, Article III.D.**
20 **as adopted by Legislative Order No. 01-431); and**
- 21 **WHEREAS, the Domestic Affairs Committee has interviewed qualified TERO Commission**
22 **applicants, one of whom, when appointed, will serve a term commencing on the**
23 **effective date of this resolution and expiring February 1, 2015 or until his successor is**
24 **appointed and qualified; and**
- 25 **WHEREAS, the Legislative Council interviewed TERO Commission candidate Norman Garcia**
26 **during Council's June 2012 general session.**
- 27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
28 **appoints Norman Garcia to the TERO Commission commencing upon the effective**
29 **date of this resolution and expiring February 1, 2015 or until his successor is**
30 **appointed and qualified.**



4 Council by Article VI Section 1 (b) and 1 (c)(2) of the Constitution of the Tohono O'odham Nation,
5 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
6 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
7 of June 18, 1934 (48 Stat. 984).
