Water Resources Department FY2012 SAWRSA budget 021-12-4520, in accordance with
the budget attached hereto.

Chairperson and any designated official to expend and administer the Budget, as
attached, provided that any Amendments affecting the funds or funding level is
submitted for further prior approval by the Tohono O'odham Legislative Council.
