

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Pisinemo District FY 2012 Administration Budget Amendment #2
in the amount of \$10,513.22)

RESOLUTION NO. 12-198

1 WHEREAS, the Tohono O'odham Legislative Council hereby amends the Pisinemo District FY 2012
2 District Administration budget to cover over expenditures and anticipated cost for the
3 remainder of the fiscal year; and

4 WHEREAS, the Pisinemo District Administration submitted a proposal to amend its FY 2012
5 Budget by deducting certain line items and adding it to other line items; and

6 WHEREAS, deductions were made from the following line items and amounts:

7	610	Salaries	\$9,138.22
8	640	<u>Per Diem</u>	<u>\$1,375.00</u>
9	Total		\$10,513.22; and

10 WHEREAS, the amount of \$10,513.22 was divided between the following line items;

11	612	Occasional Appointment	\$ 167.65
12	810	<u>Professional Services</u>	<u>\$10,345.57</u>
13	Total		\$10,513.22

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports
15 Pisinemo District Budget Amendment #2 in the amount of \$10,513.22 and the base
16 amount of \$1,660,996.79 does not change.

17 BE IT FINALLY RESOLVED that any amendments affecting the funds or funding level shall be
18 submitted for further prior approval by the Tohono O'odham Nation
19 Legislative/District Council.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day
21 of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;
22 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,
23 Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
24 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
26 Stat. 984).




