

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Gu Achi District Administration Fiscal Year 2012 Budget Amendment #2)**

RESOLUTION NO. 12-200

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these funds**
4 **shall be pursuant to appropriations or budgets" authorized by resolution or**
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, on May 19, 2012, at a regularly scheduled meeting, the Gu Achi District Council**
7 **approved Gu Achi District Administration Fiscal Year 2012 budget amendment #2 to**
8 **rename the "Land Use Committee" to "Land Use Plan Task Force" in line item 640-**
9 **Committee Fees (Gu Achi District Council Resolution #1205-209); and**

10 **WHEREAS, the Budget and Finance Committee has reviewed the Gu Achi District Administration**
11 **FY 2012 budget amendment #2 and recommends approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
13 **the Gu Achi District Administration Fiscal Year 2012 budget amendment #2 as**
14 **attached hereto.**

15 **BE IT FINALLY RESOLVED that any amendments affecting the funding level of the Gu Achi District**
16 **Fiscal Year 2012 budget shall be submitted to the Tohono O'odham Legislative Council**
17 **for prior approval.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
19 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
20 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI,**
21 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
