**RESOLUTION NO. 12-203**

1 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 11-454 appropriated the**  
2 **FY2012 Gaming Revenues the Equal Distribution amount of \$1,660,996.79, 15% of the**  
3 **Host Share in the amount of \$39,962.04, for a total of \$1,700,958.83; and**

4 **WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 11-454 approved the**  
5 **FY2012 budget for the Hikiwan District in the amount of \$1,700,958.83; and**

6 **WHEREAS, the Hikiwan District Council by Resolution No. HDC-12-028 is requesting approval of**  
7 **the attached FY2012 Budget Amendment No. 01 for the Hikiwan District**  
8 **Administration in the amount of \$14,142.30; and**

9 **WHEREAS, the FY2012 Hikiwan District Administration's Budget Amendment No. 01 has been**  
10 **reviewed by the Budget & Finance Committee.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
12 **approves the attached FY2012 Hikiwan District Administration Budget in the amount**  
13 **of \$14,142.30.**

14 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
15 **Chairwoman and any designated official to expend and administer the budget as**  
16 **attached, provided that any amendments/modifications affecting the funds or funding**  
17 **levels shall be submitted for further prior approval by the Tohono O'odham**  
18 **Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
20 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
21 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
22 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
