9	the adoption of the FY 2013 revenue projections in the amount of \$79,015,659.99 to						
10	fund the Nation's General Fund budgets for FY 2013 including \$7,710,390.81 from the						
11	General Funds and \$2,149,215.00 from FY 2011 General Fund Surplus and						
12	\$18,806,054.18 from FY 2012 General Fund Surplus.

14	approves FY 2013 projected revenues in the amount of \$79,015,659.99 including

16	Surplus and \$18,806,054.18 from FY 2012 General Fund Surplus for the purpose of						
17	funding the FY 2013 General Fund budgets of the Tohono O'odham Nation.
