8	NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby adopt, approve and
9	appropriates \$69,669,692.75 from General Fund Revenues to fund the Executive
10	Branch Fiscal Year 2013 Budget, which is approved.
11	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes
12	the expenditure of funds appropriated to and in accordance with the Executive Branch
13	FY 2013 Budget for the period beginning October 01, 2012 ending September 30, 2013.
14	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
15	Chairperson and any designated official to expend and administer the budget as
16	attached, provided that any amendments affecting the funds or funding level is
17	submitted for further prior approval by the Tohono O'odham Legislative Council.
