5	or budgets" authorized by resolution or ordinance (Constitution of the Tohono
6	O'odham Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS, the Legislative Branch has prepared and submitted for review and approvalits FY 2013
8	Legislative Branch Budget, which is incorporated by this reference; and
9	WHEREAS, the Legislative Branch distributed a courtesy copy of the FY 2013 Legislative Branch
10	Budget to all Councilmembers, Staff and all Districts; and
11	WHEREAS, the Budget and Finance Committee of the Legislative Council have reviewed this
12	Budget and recommend its approval and adoption.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
14	and authorizes expenditure of the FY 2013 Legislative Branch in the amount of
15	\$3,449,361.71, as per the attached budget, beginning October 1, 2012 and ending
16	September 30, 2013.
17	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
18	Chairperson and any designated official to expend and administer the Budget as
19	attached, provided that any Amendments affecting the funds or funding level is
20	submitted for further prior approval by the Tohono O'odham Legislative Council.
