5	the needs of the Branch for the 2013 fiscal year, a copy of the proposed said budget is
6	attached hereto and incorporated herein by reference; and
7	WHEREAS, the proposed FY 2013 Judicial Branch budget includes personnel expenses in the
8	amount of \$5,383,739.20 and operational costs in the amount of \$512,866.33, totaling
9	\$5,896,605.53 for FY 2013; and
10	WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the Legislative
11	Council have reviewed this budget and recommend its approval and adoption.
12	NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council has reviewed and
13	approves the Fiscal Year 2013 budget for the Tohono O'odham Judicial Branch in the
14	amount of \$5,896,605.53.
15	BE IT FURTHER RESOLVED that funds in the amount of \$5,896,605.53 is appropriated from the
16	general funds and authorized to be expended for the Fiscal Year 2013 budget of the
17	Tohono O'odham Judicial Branch.
18	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
19	Chief Judge and any designated official to expend and administer the Budget as
20	attached, provided that any Amendments affecting the funds or funding level shall be
21	submitted for further prior approval by the Tohono O'odham Legislative Council.
