

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Health and Human Services - Division
of Behavioral Health FY2013 Third Party Revenue Budget-Account No. 018-13-6240)**

RESOLUTION NO. 12-214

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health is**
2 **currently operating the Behavioral Health Division through an Indian Health Services**
3 **(I.H.S.) 638 Contract. The Seriously Mentally Ill (SMI) Program is a comprehensive Day**
4 **Treatment Program for Seriously Mentally Ill and Developmental Disabled Adults,**
5 **services which includes educational sessions on general mental health and substance**
6 **abuse, community activities, work projects, and case management. The original SMI**
7 **funds from the I.H.S. grant ended on August 31, 1990; and**

8 **WHEREAS, pursuant to Legislative Council Resolution No. 99-500, the Department of Health and**
9 **Human Services, Division of Behavioral Health, SMI Program has been collecting third**
10 **party reimbursement funds since September 1999 from the State of Arizona and has**
11 **since accumulated funds; and**

12 **WHEREAS, the Division of Behavioral Health, has accumulated funds to cover the Third Party**
13 **Revenue Budget Account No. 018-13-6240 in the amount of \$356,758.07 for FY2013**
14 **personnel and operational expenses (October, 01 2012 to September 30, 2013); and**

15 **WHEREAS, the Department of Health and Human Services, Behavioral Health Division request to**
16 **continue to cost share the Project Administrator position at 20% and fringe benefits**
17 **to reflect the salary from October 1, 2012 to September 30, 2013, and add salaries to**
18 **cost share the Program Manager, Senior position at 20%; and two (2) Security Officers**
19 **at 14.29% each and fringe benefits for all positions to reflect the salary from October**
20 **1, 2012 to September 30, 2013; and**

21 **WHEREAS, a Third Party Revenue budget in the amount of \$356,758.07 for FY2013, has been**
22 **submitted for review and approval by the Department of Health and Human Services,**
23 **Division of Behavioral Health; and**

24 **WHEREAS, the Health and Human Services Oversight Committee and the Budget and Finance**
25 **Committee of the Legislative Council have reviewed this budget and recommend its**
26 **approval and adoption.**

27 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 28 **1. The attached FY2013 Third Party Revenue Budget in the amount of \$356,758.07 to**
29 **supplement the FY2013 Department of Health and Human Services, Division of**
30 **Behavioral Health Budget is hereby approved to expend such funds in an amount**


1 not to exceed \$356,758.07 to supplement the Division of Behavioral Health FY2013
2 budgets.

- 3 2. Continue to cost share the Project Administrator position at 20% and fringe
4 benefits to reflect the salary from October 1, 2012 to September 30, 2013, and add
5 salaries to cost share the Program Manager, Senior position at 20%; and two (2)
6 Security Officers at 14.29% each and fringe benefits for all positions to reflect the
7 salary from October 1, 2012 to September 30, 2013.

8 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the
9 Chairperson and any designated official to expend and administer the budget as
10 attached, provided that any amendments affecting the funds or funding level is
11 submitted for further prior approval by the Tohono O'odham Legislative Council.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day
13 of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;
14 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,
15 Section 1 (d)(2) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
16 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
18 Stat. 984).


