

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Department of Health and Human Services, Division of Family Assistance - FY2013 Food Distribution Program Budget - Account No. 500-13-6331)**

**RESOLUTION NO. 12-216**

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**  
2 **Assistance Division, Food Distribution Program under an FY2012 grant with the United**  
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham**  
5 **Nation and the people; and**

6 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to apply for FY2013 United**  
7 **States Department of Agriculture funds to assist eligible individuals and families with**  
8 **commodity foods; and**

9 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
10 **of the Legislative Council have reviewed this budget and recommend its approval and**  
11 **adoption.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **and authorizes the FY2013 Food Distribution Program budget in the amount of**  
14 **\$240,067.61 in accordance with the attached budget and to utilize the Nation's**  
15 **resources pending reimbursement from the Grantor for the continuation of the Grant.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Chairperson and any designated official to expend and administer the budget as**  
18 **attached, provided that any amendments affecting the funds or funding level shall be**  
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
21 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
23 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
