

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance – FY2013 Food Distribution Program Nutrition Education Funding Budget Account No. 500-13-6332)**

RESOLUTION NO. 12-217

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY2012 grant with the United**
3 **States Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages**
5 **(commodity foods) and nutrition education to eligible households through tailgate**
6 **runs throughout the Nation and nearby towns; and**

7 **WHEREAS, nutrition education funds have been made available to the Tohono O'odham Nation**
8 **for FY2013 through the USDA in the amount of \$1,800.00; and**


9 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
10 **of the Legislative Council have reviewed this budget and recommend its approval and**
11 **adoption; and**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
13 **authorizes the expenditure of the FY2013 Food Distribution Nutrition Education**
14 **budget in the amount of \$1,800.00 in accordance with the attached budget and to**
15 **utilize the Nation's resources pending reimbursement from the Grantor for the**
16 **continuation of the Grant.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget as**
19 **attached, provided that any amendments affecting the funds or funding level shall be**
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
22 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**
24 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**


