(Approval of the FY 2013 Tohono O'odham Department of Health and Human  
Services, Division of Community Health – Women, Infants and Children (WIC)  
– ITCA Program Proposed Budget of \$185,625.00, Account 650-13-6261)**

**RESOLUTION NO. 12-220**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Women, Infants, and**  
2 **Children (WIC) Program under the oversight of the Tohono O'odham Department of**  
3 **Health and Human Services-Division of Community Health Services; and**

4 **WHEREAS, the WIC Program provides services to prevent health problems and improve the**  
5 **health of clients during critical times of growth and development; and**

6 **WHEREAS, the services provided to eligible clients have been beneficial and services continue to**  
7 **be necessary to help alleviate nutritional health risks and improve the health of**  
8 **individuals at risk; and**

9 **WHEREAS, the Inter-Tribal Council of Arizona through an Intergovernmental Agreement receives**  
10 **funds from the United States Department of Agriculture for programs designed to**  
11 **benefit women, infants and children; and**

12 **WHEREAS, the Tohono O'odham Nation has entered into a Memorandum of Agreement with the**  
13 **Inter-Tribal Council of Arizona to fund and operate the Women Infants and Children**  
14 **(WIC) Program which commenced on October 01, 2012 through September 30, 2015,**  
15 **which was approved through resolution; and**

16 **WHEREAS, the Inter Tribal Council of Arizona assigned caseload is 1000 and grant level is**  
17 **\$185,625.00 for the Women, Infants and Children (WIC) program effective October 1,**  
18 **2012; and**

19 **WHEREAS, the Women, Infants, and Children (WIC) has submitted the FY 2013 WIC Budget and**  
20 **proposal in the amount of \$185,625.00; and**

21 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**  
22 **of the Legislative Council have reviewed this Budget and recommend its approval and**  
23 **adoption.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
25 **approve and authorize expenditures of the FY 2013 attached budget in the amount of**  
26 **\$185,625.00 from the Inter-Tribal Council of Arizona to continue program operation**  
27 **and continue provided services to eligible women, infants and children and to utilize**  
28 **the Nation's resources pending reimbursement from the Grantor for the continuation**  
29 **of the Grant.**



7 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
8 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
9 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
10 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
11 **Stat. 984).**






