7	WHEREAS, the Tohono O'odham Nation Domestic Violence Program under the Division of
8	Community Health Services was awarded \$900,000.00 for the three year grant period
9	and is currently in its third year of implementation for this grant award; and
10	WHEREAS, a budget of \$299,882.93 has been prepared for Fiscal Year 2013; and
11	WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee
12	of the Legislative Council have reviewed this Budget and recommend its approval and
13	adoption.

15	and authorizes:
16	1. A budget of \$299,882.93 for Fiscal Year 2013 attached hereto.

18	continuation of the grant.

20	Chairperson and any designated official to expend and administer the budget as
21	attached, provided that any amendments affecting the funds or funding level is
22	submitted for further prior approval by the Tohono O'odham Legislative Council.
