

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Arizona Long Term Care Services (ALTCS) number 600-13-6200 Budget
for Fiscal Year 2013--October 1, 2012 – September 30, 2013)

RESOLUTION NO. 12-223

1 **WHEREAS, the Tohono O'odham Nation has an Intergovernmental Agreement with the State of**
2 **Arizona to provide Arizona Long Term Care Services (ALTCS) Case Management**
3 **services to eligible enrolled members; and**

4 **WHEREAS, the Tohono O'odham Nation has provided ALTCS case management services since June**
5 **1996 and is reimbursed from the State of Arizona for the services; and**

6 **WHEREAS, the fiscal year 2013 Arizona Long Term Care Services (ALTCS) Program budget of**
7 **\$524,138.59; and**

8 **WHEREAS, all Arizona Long Term Care Services (ALTCS) Program reimbursements obtained by**
9 **the Division of Senior Services; including all savings from previous year budgets shall**
10 **continue to be applied to the Arizona Long Term Care Services (ALTCS) base budget for**
11 **current operations; and**

12 **WHEREAS, the Health and Human Services Oversight Committee and the Budget and Finance**
13 **Committee of the Legislative Council have reviewed this budget and recommend its**
14 **approval and adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
16 **approves:**

- 17 **1. The FY 2013 Arizona Long Term Care Services (ALTCS) budget of \$524,138.59.**
- 18 **2. That all Arizona Long Term Care Services (ALTCS) Program client reimbursement**
19 **fund obtained by the Division of Senior Services; including savings from previous**
20 **year ALTCS budgets continue to be applied to the Arizona Long Term Care Services**
21 **(ALTCS) Program base budget for current operations and to utilize the Nation's**
22 **resources pending reimbursement from the Grantor for the continuation of the**
23 **Grant.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Chairperson and any designated official to expend and administer the budget as**
26 **attached, provided that any amendments affecting the funds or funding level shall be**
27 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
29 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**
30 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI,**
31 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
32 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**






