

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Department of Health and Human Services,
Division of Community Health Services, Public Health Preparedness and
Response - Bioterrorism (BT) FY 2013 Budget)

RESOLUTION NO. 12-224

1 WHEREAS, the Tohono O'odham Nation is concerned with the health, welfare and safety of its
2 members who reside on or near the Tohono O'odham Nation Reservation, including
3 the O'odham in Mexico; and

4 WHEREAS, Public Health Preparedness and Response for Bioterrorism is within the charter of the
5 Tohono O'odham Department of Health and Human Services, Division of Community
6 Health Services; and

7 WHEREAS, by Resolution No. 09-123, a new IGA for the period August 9, 2008 through August 8,
8 2013 was approved by the Tohono O'odham Legislative Council.

9 WHEREAS, the budget has been reviewed by the Budget Office, Grants & Contracts, Executive
10 Office, Health Committee and Budget & Finance Committee of all which recommend
11 for acceptance and approval by the Legislative Council.


12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:

- 13 1. Approves the 2013 Bio Terrorism budget in the amount of \$65,000.00.
- 14 2. Authorizes the Nation to obligate and expend funds upon approval of this
15 resolution.
- 16 3. Authorizes the utilization of the Nation's resources pending reimbursement from
17 the Grantor for the continuation of the Grant

18 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
19 Chairperson and any designated official to expend and administer the Budget as
20 attached, provided that any amendments affecting the funds or funding levels is
21 submitted for further prior approval by the Tohono O'odham Legislative Council.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day
23 of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;
24 -01- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,
25 Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
26 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).
