

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2013 Department of Health and Human Services Title IV-B,  
Subpart 1, Account No. 300-13-6054 and Subpart 2, Account No. 300-13-6055  
Budgets for Division of Child Welfare; and Approving the 10% Indirect Cost Rate  
for Title IV-B Budgets)**

**RESOLUTION NO. 12-225**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division**  
4 **of Child Welfare Services to intervene against child abuse and neglect and to promote**  
5 **safe and stable families; and**

6 **WHEREAS, the Title IV -B, Subparts 1 & 2 grants require a 25% match, which the Nation matches**  
7 **through the P.L. 93-638 master contract, specifically the BIA Social Services budget for**  
8 **child welfare services and the BIA ICWA budget for Family Preservation Program; and**

9 **WHEREAS, these Title IV -B, Subparts 1 & 2 Budgets are authorized for only a two year expenditure**  
10 **period, beginning October 1, 2012 and ending September 30, 2013, funding only the**  
11 **two fiscal years of FY 2013 and FY 2014; and**

12 **WHEREAS, the Department of Health and Human Services has provided estimated allocation**  
13 **amounts for these budgets as:**

- 14 1. \$131,226.98 for Title IV-B, Subpart 1 Budget, Acct. No. 300-13-6054.
- 15 2. \$226,313.00 for Title IV-B, Subpart 2 Budget, Acct. No. 300-13-6055; and

16 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and**  
17 **Families (ACF), has notified the Department that The Child and Family Services**  
18 **Improvement Act of 2006 (Public Law 109-288) restricts administrative costs to 10%**  
19 **starting October 1, 2007; and**

20 **WHEREAS, the Health and Human Services Oversight Committee and the Budget and Finance**  
21 **Committee of the Legislative Council have reviewed these budgets and recommend**  
22 **approval and adoption.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
24 **approve and authorize the Executive Branch to expend funds for the budgets attached,**  
25 **effective October 1, 2012 through September 30, 2013 in the following amounts:**

- 26 1. Title IV-B, Subpart 1 Budget in the amount of \$131,226.98.
- 27 2. Title IV-B, Subpart 2 Budget in the amount of \$226,313.00
- 28 3. To restrict the Indirect Cost to 10% in Title IV-B budgets as required by The Child  
29 and Family Services Improvement Act of 2006 (Public Law 109-288).



4. To utilize the Nation's resources pending reimbursement from the Grantor for the continuation of the Grant.



The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1 (d)(2)(3) & 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
