

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2013 Department of Health and Human Services Head Start Budget)**

**RESOLUTION NO. 12-227**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Head**  
4 **Start Program to provide educational, health, mental health and parent involvement**  
5 **services to children, three to five years of age; and**

6 **WHEREAS, this budget does not include IDC as the agency will not allow IDC to be charged**  
7 **without a current year IDC authorization letter; and**

8 **WHEREAS, Human Resource Development Committee and the Budget and Finance Committee**  
9 **of the Legislative Council have reviewed this Budget and recommend its approval and**  
10 **adoption.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**  
12 **and approves the FY 2013: Head Start Program Budget - \$1,726,855.00 with no IDC and**  
13 **Head Start T&TA Budget - \$23,205.00 with no IDC and to utilize the Nation's Resources**  
14 **pending reimbursement from the Grantor for the continuation of the grants.**

15 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Executive Branch to expend funds for the program listed above and as attached in the**  
17 **amount indicated, effective November 1, 2012 through October 31, 2013.**



20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
21 **Chairperson and any designated official to expend and administer the Budget as**  
22 **attached, provided that any amendments affecting the funds or funding level is**  
23 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
25 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,100.30 FOR; -0- AGAINST;**  
26 **-0- NOT VOTING; and 680.30[10] ABSENT, pursuant to the powers vested in the Council by Article**  
27 **VI, Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**
