5	services to children, three to five years of age; and
6	WHEREAS, this budget does not include IDC as the agency will not allow IDC to be charged
7	without a current year IDC authorization letter; and
8	WHEREAS, Human Resource Development Committee and the Budget and Finance Committee
9	of the Legislative Council have reviewed this Budget and recommend its approval and
10	adoption.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts
12	and approves the FY 2013: Head Start Program Budget - \$1,726,855.00 with no IDC and
13	Head Start T&TA Budget - \$23,205.00 with no IDC and to utilize the Nation's Resources
14	pending reimbursement from the Grantor for the continuation of the grants.
15	BE IT FURTHER RESOLVED that the Tohono O O'odham Legislative Council hereby authorizes the
16	Executive Branch to expend funds for the program listed above and as attached in the
17	amount indicated, effective November 1, 2012 through October 31, 2013.

19	2. Head Start T & TA Budget - \$23,205.00 with no IDC.
20	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
