14	Department of Education through the Child and Adult Care Food Program Services
15	Agreement, to reimburse funds for food costs incurred based on the guidelines
16	identified in the agreement.

18	Chairperson and any designated official to expend and administer the Budget as
19	attached, provided that any amendments affecting the funds or funding level is
20	submitted for further prior approval by the Tohono O'odham Legislative Council.
