

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2013 Arizona Reimbursable Budget: Child and Adult Care Food Program)**

**RESOLUTION NO. 12-229**

1 **WHEREAS, the Tohono O'odham Nation has historically sought reimbursement through an**  
2 **agreement from the State of Arizona; and**

3 **WHEREAS, the Arizona Department of Education through the Child and Adult Care Food Program**  
4 **Service Agreement provided reimbursement of funds for food costs incurred based on**  
5 **the guidelines identified in the agreements; and**

6 **WHEREAS, the Human Resources Development Committee and the Budget and Finance**  
7 **Committee of the Legislative Council have reviewed this Budget and recommend its**  
8 **approval and adoption.**


9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
10 **the Child and Adult Care Food Program Budget in the amount of \$86,738.60 and**  
11 **authorizes to expend funds for the program listed herein, effective October 1, 2012**  
12 **through September 30, 2013.**

13 **BE IT FURTHER RESOLVED that the Executive Branch will seek reimbursement from the Arizona**  
14 **Department of Education through the Child and Adult Care Food Program Services**  
15 **Agreement, to reimburse funds for food costs incurred based on the guidelines**  
16 **identified in the agreement.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
18 **Chairperson and any designated official to expend and administer the Budget as**  
19 **attached, provided that any amendments affecting the funds or funding level is**  
20 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
22 **of JUNE, 2012 at a meeting at which a quorum was present with a vote of 2,780.60 FOR; -0- AGAINST;**  
23 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
24 **Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
25 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
