6	Budgets as attached and incorporated by this reference, to be effective October 1, 2012
7	through September 30, 2013 and requests authorization to expend funds for the FY
8	2013 Child Care and Development Fund (CCDF) in the amount of \$1,034,425.00 in the

	following budgets:
10	1. FY 2013 CCDF Mandatory Funds - \$564,029.77 + \$85,593.23 (IDC) = \$649,623.00.
11	2. FY 2013 CCDF Discretionary Funds - \$325,177.25 + \$59,624.75 (IDC) = \$384,802.00
12	NOW, THEREFOR, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
13	the above listed CCDF Mandatory Funds Budget, and CCDF Discretionary Funds
